This column reflects whether the state system is able to make real-time eligibility determinations, defined as within 24 hours. Not all states have programmed their eligibility systems to make real-time determinations without worker interaction. In some states, only a small share of applications completed in person or over the phone that can be verified by an eligibility worker immediately are processed in real time.
- 2. These columns indicate the share of applications for non-disabled groups (children, pregnant women, parents, and expansion adults) that are determined eligible in real-time.
- 3. This column indicates whether the state checks against other databases on a routine basis for changes in circumstances that would affect eligibility for enrollees.
